### Transurban new operating model

Transurban Group today announces a new operating model to support the Group's strategic growth agenda.

The new operating model includes the creation of four new executive roles: Chief Commercial Officer; Group Executive Australian Markets; Group Executive Delivery and Risk; and Group Executive Corporate Affairs (see Appendix 1).

Transurban Group Chief Executive Officer Michelle Jablko said the changes would help the Group build on its strong foundation with further growth and a strong stakeholder focus.

"I am delighted that Hugh Wehby, Group Executive Partners, Delivery and Risk has been appointed Chief Commercial Officer, and Nicole Green, Acting Group Executive Victoria, has been appointed Group Executive Australian Markets", Ms Jablko said.

"There are significant opportunities ahead, but we need to evolve the way we grow.

"These changes to how we operate will help achieve that, by removing complexity and creating further simplicity and efficiency that will best position us going forward."

With this change in operating model, the roles of Group Executive NSW, Group Executive Queensland and Group Executive Victoria are no longer required.

"I would like to thank Sue Johnson and Michele Huey for the roles they have played in our growth over many years," Ms Jablko said.

Transurban Group confirms that there is no change to the existing roles of Chief Financial Officer, Group Executive People and Culture, Group Executive Customer and Technology and President North America.

An executive search has commenced for the Group Executive Delivery and Risk and Group Executive Corporate Affairs positions.
